European Union (EU27) Plastics Industry - Economic Summary



Overview

The positive development of the EU27 Plastics Industry after the bounce back from the great recession continued until the beginning of 2011. Since the 2nd quarter 2011 Primary Plastics showed decreasing tendencies, but now remains stable since November 2011. Also Plastics Products remain more or less stable since mid 2011. After a long period of strong recovery, the Plastics Machinery sector seems to have shifted to a sideway movement during recent months.

Sectors

Across sectors, developments in the beginning of 2012 were somewhat uneven. **Production quantities** of Primary Plastics show slightly increasing tendencies in 2012 while Plastics Products and Plastics Machinery production remain more or less stable during the last months.

Plastics Industry **producer prices** increase in all sub categories since the beginning of 2012, after a period of stagnating or partly decreasing development. Especially prices for Primary Plastics show a strong growth during the last months.

End use Industries

The Electrical Machinery Industry's production shows a sideway movement since mid 2011. The upward trend in the Automotive sector came to an end in mid 2011 and seems to have shifted into a period of more or less stable production figures. Production figures for the construction industry decrease again since fourth quarter of 2011 after almost two years of consolidation. Production in the more crisis-resistant Food and Beverages sector further on with a more or less sideway movement.

External Trade


Total export quantities of Primary Plastics have reached its peak at the end of 2010. The first half of 2011 showed decreasing export tendencies, but since the second half year export quantities show a more or less constant development. Exports of Plastics Products decreased in the first half of 2011 but show increasing tendencies again since mid 2011. Total import quantities show a slight increase for Primary Plastics and a primarily decreasing trend for Plastics Products.

Outlook

The stable development of production figures for Primary Plastics and Plastics Machinery at the beginning of 2012 as well as increasing producer prices for all sectors give slightly positive signals for the future. However, some important customer industries indicate more stable production trends in recent months.

European Union (EU27) Plastics Industry Production






Actual data status of Production: 04/2012

Plastics Industry Production by long term view (1992-2012):

- Long time series shows strong growth for production of Primary Plastics and Plastics Products during the 1990's and a more sideways development from 2000 to 2005. Plastics Machinery shows a more fluctuating development in long-term view.
- After strong growth in all the three segments in 2006 and more constant development in 2007, the effects of the economical crisis are clearly recognizable in 2008 and first half of 2009.
- Economic recovery since mid 2009 in all the three segments: Plastics in Primary Forms, Plastics Products and Plastics Machinery.

Plastics Industry Production by short-term view (last 12 months):

- After months of strong growth, Plastics Machinery with sideway movement since October 2011.
- The development of Plastics Products production shows a sideway movement during the last months.
- The decline in production figures for Plastics in Primary Forms has stopped at the end of 2011. Since January 2012 a slightly increasing production trend was recorded.



- The first four months of 2012 show increasing production figures compared to the same period in 2011 for the Plastics Machinery sector, which grew by 7.5%.
- Production of Primary Plastics (-3.1%) and Plastics Products (-1.6%) show a slight decrease compared to 2011.
- Production indices for Plastics Products and Plastics Machinery remain more or less stable since the beginning of 2012. Production of Primary Plastics even shows a slight increase in the first four months.

- From mid 2009 to end of 2010 main segments of Plastics Products, except "Builders", have recovered strongly after the deep recession.
- 2011 showed slightly decreasing trends for most of the Plastics Products sub-categories except for the "Others"-segment, which showed growing tendencies.
- From January to April 2012 production indices for most of the Plastics Products sub-categories remain more or less stable. The "Others"-segment decreases slightly.




- Compared to the same period in 2011, production figures for January to April 2012 decreased within all of the Plastics Products sub-categories except for "Others".
- The strongest decline was recorded for "Plates, Sheets, Tubes and Profiles" with -3.7%.
 "Other Plastics Products" showed a slight growth compared to the same period in 2011 (+0.5%).
- "Others" with a slight decline in recent months. All other subcategories with more or less constant development in the first four months of 2012.


European Union (EU27) GDP, Chemical and Plastics Industry





- EU27 GDP increased by 1.5% in 2011, compared to 2010.
- In the first quarter of 2012 the GDP decreased by 0.02% compared to fourth quarter of 2011.
- Actual estimations of Eurostat for EU27 GDP growth rates (year on year): 2012: +/-0%, 2013: +1.3%






- Uptrend in the Total Manufacturing industry hast lasted until the first quarter of 2011. Since then, slightly decreasing tendencies were recorded. Chemical industry with sideway movement in 2012.
- More or less constant development for production of Primary Plastics, Plastics Products and Plastics Machinery in recent months.

European Union (EU27) Plastics Customer Industries - Part I






Actual data status of Production: 04/2012

- Recovery in the EU27's Manufacturing Industry since 2009, but with slightly decreasing tendency since the second quarter of 2011 again.
- After strong growth especially in 2009 and 2010, Automotive industry with slightly decreasing tendencies since mid 2011.
- Sideway movement in the Electrical Machinery Industry since mid 2011.
- Industrial production activity in the EU27 is still below the pre-crisis level.

European Union (EU27) Plastics Customer Industries - Part II






- Decreasing production trend in the Construction Industry since the third quarter of 2011.
- The Food and Beverages Industry was less hit by the recession than other industries.
- Slightly decreasing trend in production figures of the Manufacturing Industry since mid 2011.


- Total EU27 Export quantity of Primary Plastics has reached its peak at the end of 2010. The same applies to EU27 Extra Exports.
- Import quantities from Extra EU27 as well as Total Imports show a slightly increasing trend since the end of 2011.
- During the last years the Extra EU Import share grew to 15.3% in 2011. The Extra EU Export share from January to March 2012 (26.1%) was slightly lower than in 2011 (26.5%).



- After two years of Total Exports growth, quantities in 2011 showed primarily decreasing tendencies. Since September 2011 Total Exports grow again. Total Imports show a primarily decreasing trend since 2011.
- Extra EU Imports and Extra EU Exports increased in 2009 and 2010, but now show more or less constant tendencies.
- The share of Extra EU Imports and Extra EU Exports increased in recent years.

 Record trade surplus of EU27 Primary Plastics Industry with Non-Member Countries in 2009. 2010 and 2011 with a slightly lower trade surplus.



- Since December 2011, a decreasing trend of the trade surplus for Primary Plastics can be observed.
- Since 2004 Plastics Products have registered a stable surplus in Extra EU trade of about 1 Mio tons per year.


- With regard to the business outlook for the months ahead, a stable majority of companies reports positive production expectations.

Remark:

After consulting VDMA and Eurostat, the jump in the price series with Plastics Machinery from 2009 to 2010 comes from a country that has supplied confidential data (UK, Sweden or Spain)

Actual data status of Production: 04/2012

- Fluctuating trend of Primary Plastics, Plastics Products and Plastics Machinery output prices during the last years.
- Primary Plastics prices with strong continuing growth after a short period of decrease in the second half of 2011.
- Prices for Plastics Products with steady growth over the last years.
- After some months of stable price development in the Plastics Machinery segment in 2011, prices increase again since the end of the year.

Primary Plastics

Compared to the same period in 2011, prices increased by 1.9% in the first four months of 2012. Strong increase since February after some months of decline.

Plastics Products

With +1.9% the Plastics Products segment showed an increasing price trend at the beginning of 2012 compared to the same period in 2011. Prices clearly increase since February 2012 after a period of stagnation.

Plastics Machinery

Compared to 2011, prices for Plastics Machinery in the first four months of 2012 had been 4.1% higher. Increasing trend in recent months can be recorded.

Classification of Economic Activities: New Nace Rev.2 Classification of Eurostat since 2009

Sectors of the plastics industry are classified by the following NACE codes: C2016 (Plastics in Primary Forms), C222 (Manufacture of Plastics Products), C2221 (Plates, Sheets, Tubes and Profiles), C2222 (Packaging), C2223 (Builders), C2224 (Others), C2896 (Plastics Machinery incl. Rubber)

Main plastics related industries NACE codes: C10_12 (Food and Beverages), C20 (Chemical Industry excl. Pharmaceuticals), C26_27 (Electrical Machinery), C291 (Automotive), F (Construction)

Production index (base year 2005 = 100) is presented as "working-day-adjusted" and as "Trend-cycle". The Trend-cycle is calculated by smoothing averages from working-day and seasonally adjusted data. Eurostat uses statistically and internationally accepted methods (Census X-12) for the seasonal adjustment of time series. With first publication of production indices for 2012, Eurostat changed from a direct to an indirect method of seasonal adjustment. The new method is applied to the complete time-series of production indices. This also affects data before 2012.

The producer price index for the plastics industry (base year 2005 = 100) measures the average price development of all goods resulting from that activity that are sold on the domestic market and foreign markets. The producer price index for the plastics industry is divided by Nace C2016 (Plastics in Primary Forms), C222 (Manufacture of Plastics Products) and C296 (Plastics Machinery incl. Rubber)

GDP real: Gross Domestic Product at 2000 prices and exchange rates, seasonally adjusted

Business Surveys: The results of the business surveys are based on representative samples of companies in the EU27 Plastics Products Industry (incl. Rubber Industry). Managers' answers obtained from the surveys are aggregated in the form of "Balances". Balances are constructed as the difference between the percentages of respondents giving positive and negative replies. The EU Commission seasonally adjusts the balance series.
